Dorchester Minerals, L.P. Announces Its Third Quarter Distribution

DALLAS, TEXAS — Dorchester Minerals, L.P. (NASDAQ:DMLP) announced today the Partnership's third quarter 2021 cash distribution. The distribution of \$0.507608 per common unit represents activity for the three-month period ended September 30, 2021 and is payable on November 10, 2021 to common unitholders of record as of November 1, 2021.

Cash receipts attributable to the Partnership's Royalty Properties during the third quarter totaled approximately \$17.3 million. Approximately 77% of these receipts reflect oil sales during June 2021 through August 2021 and gas sales during May 2021 through July 2021, and approximately 23% from prior sales periods. Cash receipts attributable to the Partnership's Net Profits Interests during the third quarter totaled approximately \$3.3 million. Approximately 77% of these receipts reflect oil sales and gas sales during May 2021 through July 2021, and approximately \$3.3 million.

Dorchester Minerals, L.P. is a Dallas-based owner of producing and non-producing oil and natural gas mineral, royalty, overriding royalty, net profits, and leasehold interests located in 26 states. Its common units trade on the Nasdaq Global Select Market under the symbol DMLP.
