

## Dorchester Minerals, L.P. Announces Second Quarter Results

DALLAS, TX -- (Marketwired) -- 08/04/16 -- Dorchester Minerals, L.P. (the "Partnership") (NASDAQ: DMLP) announced today the Partnership's net income for the quarter ended June 30, 2016 of \$5,951,000, or \$0.19 per common unit.

The Partnership previously declared its second quarter distribution in the amount of \$0.257977 per common unit payable on August 11, 2016 to common unit holders of record as of August 1, 2016. The Partnership's cash distributions are not comparable to its net earnings due to timing and other differences including depletion.

Dorchester Minerals, L.P. is a Dallas based owner of producing and non-producing crude oil and natural gas mineral, royalty, overriding royalty, net profits, and leasehold interests and its common units trade on the NASDAQ Global Select Market under the symbol DMLP.
