



Dorchester Minerals, L.P. Announces Second Quarter Results

DALLAS, Aug. 07, 2025 (GLOBE NEWSWIRE) -- Dorchester Minerals, L.P. (the "Partnership") (NASDAQ-DMLP) announced today the Partnership's net income for the quarter ended June 30, 2025 of \$12,347,000, or \$0.25 per common unit.

The Partnership previously declared its second quarter distribution in the amount of \$0.620216 per common unit payable on August 14, 2025 to common unitholders of record as of August 4, 2025. The Partnership's cash distributions are not comparable to its net earnings due to timing and other differences including depletion.

Dorchester Minerals, L.P. is a Dallas based owner of producing and non-producing oil and natural gas mineral, royalty, overriding royalty, and net profits interests located in 28 states. Its common units trade on the NASDAQ Global Select Market under the symbol DMLP.
