

Dorchester Minerals, L.P. Announces First Quarter Results

DALLAS, TX -- (Marketwired) -- 05/07/15 -- Dorchester Minerals, L.P. (the "Partnership") (NASDAQ: DMLP) announced today the Partnership's net income for the guarter ended March 31, 2015 of \$4,031,000, or \$0.13 per common unit.

The Partnership previously declared its first quarter distribution in the amount of \$0.306553 per common unit paid on May 7, 2015 to common unit holders of record as of April 27, 2015. The Partnership's cash distributions are not comparable to its net earnings due to timing and other differences including depletion.

Dorchester Minerals, L.P. is a Dallas based owner of producing and non-producing crude oil and natural gas mineral, royalty, overriding royalty, net profits, and leasehold interests and its common units trade on the NASDAQ Global Select Market under the symbol DMLP.
